Respected Colleagues,

We are all aware of the Coronavirus COVID19 situation in the Country. The Central Government, many State Government & Local Authorities are taking steps to fight this Pandemic. The key step in this fight is social isolation in the affected areas. In line with the Government Initiatives, following advisory is issued by the WIRC of ICAI for all Chapters, Extension Centers, Study Circles and ROCCs within its jurisdiction. The respective Chapters, Extension Centers, Study Circles & ROCCs are advised to take a decision based on the local conditions and local government directives. WIRC of ICAI will review the situation on 30th March 2020 and will issue further Advisory if required.

Below is the Advisory from ICAI-WIRC, the advisory is applicable till 30th March 2020.

ADVISORY

In light of the Coronavirus COVID 19, following steps are advised by the ICAI-WIRC for all Chapters, Extension Centers, Study Circles and ROCCs within its jurisdiction. The advisory is effective till 30th March 2020 and will be reviewed thereafter.

1. All the CEPs, Seminars, Members Meetings or any other program involving mass participation of Members & Students by whatever name may be called may be suspended.
2. All the Programs of Institute such as GST Course, SAP Course, Valuation Course, IAPs, etc. which are conducted at the local level may be suspended
3. All the Coaching Activities, e.g. Oral Coaching Classes, Computer Training, Industry Visits, Library Facilities, Study Room Facilities, etc. may be suspended.
4. Encourage the Faculties of CEPs to engage in Webinar using Institute Facilities.

In light of the steps initiated by the Maharashtra State Government, WIRC has decided to suspend the ongoing Pre-Campus Training at Mumbai & Pune Locations till 30th March 2020.

We advise respective authorities at other locations where Pre-Campus Training is going on to take appropriate decision considering local situation and directives by the government.

We request cooperation from all involved to fight the situation without creating any panic and showcase that we are a responsible National Institute.
