# **OEE** (Overall Equipment Effectiveness)

OEE (Overall Equipment Effectiveness) throws a light on the performance and efficiency of a manufacturing unit. **Overall Equipment Effectiveness** (OEE) is developed by <u>Seiichi Nakajima</u> in the 1960s to evaluate how effectively a manufacturing operation is utilized.

It is based on the three production related factors - Availability, Performance, and Quality that is machine availability, production performance & quality of the product produced. OEE can be applied to any individual Work Center, or group of work centers or Plant levels. This tool enables drilling down to specific analysis, such as a particular Part Number, Shift or batch.

No manufacturing unit operates at 100% efficiency, there are 'N' of factors which affects the manufacturing performance. For example – machine break down, material unavailability, substandard quality material, inexperienced workers, defective materials, machine problems etc etc. It is hence generally common that 85% operational efficiency is targeted.

# Major causes of Production efficiency losses are -

- Down time losses such as Tools failure, Equipment failure etc
- Down time losses such as unplanned maintenance, set up & change over losses etc
- Product quality related such as scrap, reworks, rejections etc
- Short stops such as speed losses due to misfeeds, delivery blocked, cleaning etc
- Operator inefficiency
- External reasons like power failure etc
- Nature of the produce

OEE is a major KPI (Key Performance Indicator) that considers three elements – Availability, Performance & Quality.

Availability of the machine is a percentage of time that machine is available (this is exclusive of preventive maintenance, planned down time activities trials, setting time etc) against the production time.

The formulae is -

# Availability = Operating time / Planned production time

Performance indicates the rate at which actual no of units produced against the standard rate for no of units which can be produced in the operating time. The formulae is –

# Performance = Ideal Cycle time / Actual Operating time

Ideal cycle time is also known as theoretical cycle time, design cycle time.

Quality is the percentage of products which is first time correct. The formulae is -

#### **Quality = Good pieces / Total Pieces**

And then considering above three factors OEE is calculated as -

**OEE** = Availability \* Performance\* Quality \*100

It is very important to note that always increased OEE is better, one need to analyze the three factors which indicates the three different areas of efficiency that is availability, quality & performance.

In the following example even if the OEE of shift one is on the higher side if we study the situations carefully we can come to know that the actual better is the performance of second shift. Availability one can improve but the quality 99.5% is very good achievement in this case.

By analyzing the three factors one can come to know the areas for improvement such as production processes, equipment or tools performance, maintenance, rejection etc.

OEE helps in -

- Reducing quality costs,
- Reducing Down time costs,
- Reducing maintenance costs,
- Improved material, machine & labour efficiencies.
- Improved bottom lines

#### Means of Improving OEE -

There can be number of ways by which one can improve the OEE, some of them can be -

- Operators training
- Technical improvements in the bottleneck machines
- Fine tuning in the production planning
- Product redesigning
- Proper Operating instructions
- Maintaining the machines in good operating conditions
- Proper & effective inventory planning
- Proper understanding of production process

For any unit one of the objective is to improve the bottom-lines. There can be two ways for improving the profits, either by increasing the selling price or by reducing the costs. In this competitive era one cannot take a risk of increasing the selling prices, but definitely can think of means of reducing the costs. As OEE increases the utilization efficiencies in almost all critical areas it can be used as one of the important tool for reducing the costs.
