Terms and conditions of engagement of Cost Trainee

i. Roles and Responsibility:

Roles and Responsibility will be assigned by Financial Adviser & Chief Accounts Officer on engagement.

ii. Period of Contract:

The Period of contract will be for three years.

iii. Stipend:

Consolidated fixed stipend of Rs.22,500/- per month with 10% increment every year will be payable. No other allowances or benefits would be admissible/paid to you. Applicable/statutory taxes will be deductible.

iv. Duty Hours:

Duty hours are from 10.00 A.M. to 6.00 P.M. from Monday to Friday or as decided by the Administration. Administration reserve the right to change the duty hours. Saturday and Sunday will be holiday.
