Requirement of CA Inter/ICWAI Inter candidate for the post of Supervisors/Finance IN MUMBAI FOR MUMBAI METRO LINE-3 PROJECT (AQUA LINE), on fixed term contractual basis initially for one year, in DMRC.

The Delhi Metro Rail Corporation (DMRC) Ltd., is a Joint Venture company with equal equity participation of the Govt. of India and the Govt. of the National Capital Territory of Delhi, for providing a rail-based Mass Rapid Transport System in Delhi and NCR.

DMRC has been awarded the contract for Operation and Maintenance work of 33.5 kms. Line 3 of the Mumbai Metro, Aqua Line, from Aarey JVLR metro station to Cuffe Parade metro station, covering a total of 27 stations, from the south of the western metropolis, to the north.

There is an immediate requirement of **ONE SUPERVISOR FINANCE** for the Operation & Maintenance work of Mumbai Metro Line - 3 (Aqua Line) in Finance department and posting will be done in MUMBAI. Applications are invited from **CA Inter/ICWAI Inter candidate**

The selected candidates shall be engaged on purely **contractual basis**, and shall have no claim of regularization, in the future. Terms and conditions are as per Annexure-I

Annexure-I

- The engagement will be on Fixed Term Contractual basis, as Supervisor/Finance on a consolidated pay of Rs. 50000/-, for Mumbai Metro Line-3, initially for a period of one year.
- The consolidated pay is inclusive of all other benefits such as Accommodation, Transport, Medical, LTA, Canteen, Insurance, etc., and subject to deduction of taxes. No other financial benefits/allowances shall be admissible.
- For Medical Coverage, the medical insurance health policy of minimum Rs. 3.5 lakhs per annum Covering COVID-19 and other diseases should be obtained, within a month of the engagement. He/She shall also enrol and obtain Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) and Pradhan Mantri Saraksha Bima Yojana (PMSBY), within a month of the engagement.
- Minimum Pf as prescribed under the EPF & MP Act 1952 will be deducted @12% on Ra 15,000-(currently) Rs. 1,800/- per month (subject to number of days) from the salary and the equivalent contribution will be made by DMRC. Gratuity shall be paid as per the Gratuity act.
- The Consolidated remuneration will remain fixed throughout the period of Fixed Term Appointment and there will be no increase in the remuneration on completion of the fixed term period. The remuneration shall be proportionately reduced in case of absence from work
- TA/DA would be admissible, if deputed on outstation duty.
- Leave entitlement shall be at the rate of 18 days Earned leave and 08 days casual leave per annum. Encashment of un-availed leave shall not be permissible during the contract, or, on resignation, or, termination of contract. The personnel shall not be eligible for any other leave other than National/ Gazetted Holidays/Weekly off, as declared by DMRC, when the DMRC/MML-3 office remains closed.
